

NARRATIVE

On 9-24-17 at approximately 1900hrs I, Officer Seth Harlow, was driving outbound on Circuit Ave when I was flagged down by an individual. I stopped my cruiser and

spoke with the male, later identified as Damjan VASIC. VASIC informed me that he lives at 3 Uncas Ave with several roommates and on three separate occasions, that night being the most recent, a man and woman had gone into their apartment unannounced. The two people in questions were standing next to VASIC and his roommates and I recognized them as Dana OLCOTT and Joel CLEMENTS. I spoke with OLCOTT and CLEMENTS separately and they told me that they never went into the house but had gone there to inquire if the landlord would rent them a small cabin on the property. They told me that they didn't want any trouble and didn't believe they had done anything wrong.

I then spoke with VASIC again and he advised me that he didn't want OLCOTT or CLEMENTS coming to their apartment again. I suggested a trespass notice be completed and he thought that would be sufficient. I completed the notice and served OLCOTT and CLEMENTS in-hand and explained the notice.
